## TOURNAMENT CONDITIONS

1. Entries to be made to: *The Tournament Director, Patterson River Country Club, The Fairway Bonbeach Vic 3196* and will only be accepted if on the official entry form, accompanied by Entry Fees and Golfink number (entries may be attached in electronic form).
2. Entries close with the Tournament Director on the March 1<sup>st</sup> 2012 or when entries are full, tee times and tee allocations will be based on a first in best dressed basis (entries will not be accepted by telephone).
3. Entries are restricted to Amateurs holding a current handicap and who must be able to produce Golfink cards if called upon to do so.
4. Competition shall be played in accordance with the Rules of Golf as adopted by the Royal and Ancient Club of St. Andrews, Scotland, together with such local rules as are in force at Patterson River Country Club. If a dispute arises on any point, it shall be decided on by the Match Committee of Patterson River Country Club, (hereinafter called the Match Committee), whose decision shall be final. Provided, however, that the Match Committee, if in doubt, shall have the right to refer any such dispute to the Council of the Victorian Golf Association and/or the W.G.V., whose decision shall then be final.
5. The Match Committee shall make all arrangements and have full power to alter the programme if necessary and reserves the right to make any alterations in the handicaps before the event is played, if deemed desirable.
6. The Starter is authorised to move players in the field from published groups to fill any gaps due to non-arrivals. Refusal to move will result in that player being deemed ineligible to commence play.
7. In the event of a tie, a count back will be decided in accordance with the recommendation of Golf Victoria, in respect to such ties. Details of the system are available on request.
8. Full clubhouse food & beverage service available throughout the event.
9. No refunds will be given for cancellations made after the draw has been completed, or for play cancelled as a result of weather conditions.

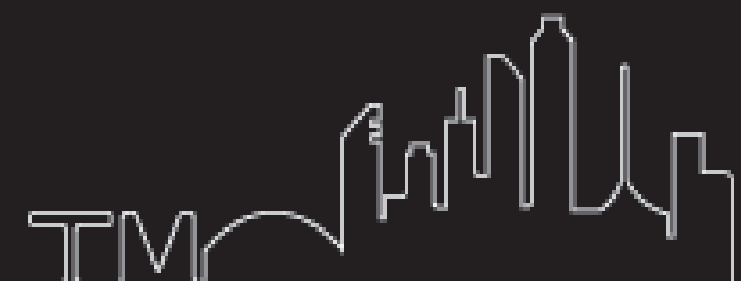
